PAPER SUBMISSION GUIDELINES

Belgrade BELLS welcomes original research papers, book reviews, scholarly interviews, and commentaries.

Manuscripts (up to 10.000 words) should be submitted electronically: belgrade.bells@gmail.com

Submission deadline: 15 June 2011

Contributions should be in English. Contributors whose native language is not English are asked to have their manuscript carefully checked by a native speaker.

Manuscripts should conform to the following STYLE SHEET:

> The paper should contain the following:

- (1) Name(s) of the author(s)
- (2) Affiliation of the author(s)
- (3) Title
- (4) Abstract
- (5) Body of the text
- (6) References

> Format

Paper size: A4

Font: Times New Roman (12 pt)

Line spacing: 1.5
Alignment: Justified

Page numbers: **Do not insert page numbers**

Author's name: **bold, aligned left**

Affiliation: below author's name, regular

Title: **bold capitals, centered**

Headings: bold, aligned left, separated from the text by a blank

line

NB: If a paper contains characters other than the Latin script, the author should provide the fonts.

> Abstract

An abstract of up to 120 words (under the heading **Abstract**) should precede the body of the text.

Emphasis

Bold should only be used for the title, subtitles, and headings.

Italics should be used for emphasis, examples interpolated in the text, non-English words and book/journal titles.

'Single quotation marks' enclose translations, e.g. Serbian ako 'if'.

"Double quotation marks" enclose brief citations running in the text (longer quotations, indented on all sides, are not put between quotation marks).

Punctuation

Periods, commas, colons and semicolons should be followed by single spaces; dashes are preceded and followed by single spaces.

> Footnotes

Footnotes should be marked consecutively throughout the text by a raised number directly following a punctuation mark.

> Figures, tables etc.

Figures, tables etc. should be provided on a separate page (with appropriate reference in the text) or inserted as moveable objects in the text.

> Examples

Examples (especially in linguistic texts) should be given in separate lines, numbered consecutively throughout the paper, aligned left. Examples from languages other than English should be glossed (where necessary) and translated into English (translations in single inverted commas). Sample example:

(1) njuutaa balde be long+2SG+SUBJ in days 'May you live long!'

> Citations and quotations

Citations and quotations are followed by parentheses containing author's surname, year of publication and a reference to page(s) - e.g. (Lyons 1977: 45). Brief citations are interpolated in the text, between double quotation marks. Longer quotations (5-10 lines) should appear as separate blocks, indented left and right and separated from the text by an extra-line space above and below, without quotation marks.

> References

- The list of references (under the heading **References**) should contain all the sources referred to in the text and only those.
- The sources are listed in alphabetical order according to the author's/editor's last name, with complete bibliographical details.
- The second line of each reference should be indented by 1.5 cm (special, hanging).
- For books with more than three authors, the first name and the abbreviation *et al.* should be used (e.g. Quirk et al. 1985).

- Book and journal titles are in *italics*.
- Titles of articles in books and journals are in regular font style.
- Page references are required for articles in books and journals.
- Online sources should be listed with complete bibliographical details, including the date of visiting the site.
